Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

## What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances, account activity and payment history
- Credit history and credit score

How? All financial companies need to share customer personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons The Nationwide Group of Companies chooses to share; and whether you can limit this sharing.

How does The Nationwide Group protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will only apply to you. We will share information about the joint accountholder unless the joint accountholder limits our sharing of personal information.

They can be financial and nonfinancial companies.</li> <li>The Nationwide Group affiliates include Hercules Insurance Agency LLC, Nationwide Acceptance LLC, Nationwide CAC LLC, Nationwide Cassel LLC, Nationwide Installment Services LLC, Nationwide Loan Company LLC dba Nationwide Finance LLC, Nationwide Loans LLC, Nationwide Northwest LLC, Nationwide Southeast LLC, Nationwide West LLC, NIKO Credit Services LLC, and Pelican Loan Company LLC.</li> </ul>	
Non- affiliates	Companies not related by common ownership or control. They can be financial & nonfinancial companies. The Nationwide Group of Companies does not share your information with nonaffiliates.	
Joint marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>As allowed by law The Nationwide Group of Companies may engage in joint marketing agreements to provide you with more financial products and services.</li> </ul>	

## Other important information

*California Residents*: We will not share your information with companies (including our affiliates) except as permitted by law, which includes to service your account or with your consent. We will not share information under a joint marketing agreement as defined above without your consent.

In addition, if we disclose information about you to other financial institutions with whom we have joint marketing arrangements, we will only disclose your name, contact information and information about your transactions.
